NOTIFICATION OF RELEASE IN RHODE ISLAND

Name of Offender: Karlheinz Rouillier

Date of Birth: 09/28/1983

Age of Offender: 23 Years Old

Description of Offender: White Male, Brown Hair, Brown Eyes, 6'0", approximately 170lbs

Resides in Area of: Abbi Lane, Hope, Rhode Island

Convicted of: Second Degree Sexual Assault

Assaulted a 16 year old female known to the offender at the time of the offense.

Community Supervision: Adult Probation Supervision EXPIRES in 2011.

RISK LEVEL TWO In addition to Level One notification (other law enforcement agencies, victims/witnesses to the offense committed by the offender) law enforcement may notify schools and daycare centers and providers and other organizations that primarily serve individuals likely to encounter the offender.

The Scituate Police is releasing the following information pursuant to RI General Laws §11-37.1-1 et seq., also known as the Sexual Offender Registration and Community Notification Act. This individual is subject to community notification of his pending release pursuant to RI General Laws §11-37.1-12 of the Act, which authorizes law enforcement agencies to inform the public of a sex offender's release from prison when the Sex Offender Board of Review determines that the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense which also requires registration with law enforcement pursuant to RI General Laws §11-37.1-1 et seq.

This offender is not wanted by the police at this time and has served the sentence imposed on him by the court. This notification is NOT to increase fear in the community. It is the belief of law enforcement that an informed public is a safe public.

No agency, including any Law Enforcement Agency or any state agency, may direct where the offender does or does not reside, nor can these agencies direct where he works or goes to school. The risk level of this offender has been determined based largely on his potential to re-offense.

Sex offenders have always lived in our communities; but it was not until passage of the Sexual Offender Registration and Community Notification Act that law enforcement even knew where they were living. In many cases, law enforcement is now able to share information with you. Abuse of this information to threaten, intimidate or harass registered offenders will not be tolerated and may be a crime. Further, such abuse could potentially end law enforcement's ability to do community notifications. We believe that if community notification ends because of community harassment, the only person who wins is the sex offender, since sex offenders derive their power through secrecy.
